Rhodeside Harwell, Inc. (RHI) with Kirkland Studio, 4:15 p.m. - 5:15 p.m.:

- Should the memorial be comprised of one iconic element to recognize the victims as a group, or should it be comprised of a series of uniquely individual elements that will convey to the visitor some key information about each of the victims?
- What activities or programs do you feel would be appropriate to accommodate at the memorial site?
- What are the security concerns at the site?
- Is there anything else you would like to tell us about your thoughts/hopes related to the design of this memorial?



Dills Architects with SWA, 5:30 p.m. - 6:30 p.m.:

- Describe the overall feeling you see for the future memorial. Examples: Serene, Intimate, Inspirational, Reflective, Linked to Nature, Peaceful, etc.
- Should the memorial be inward or outwardly focused?
- Are there themes or ideas that would convey the essence of this memorial?
- What role do the presence of materials and nature play to create the meaning and character of the memorial? Example: water, stone, trees, plantings, light, etc.
- What role do the senses play for the final feeling of the memorial? Example: touch/texture, sounds present, sight/color, quality of light, etc.?
- What features or materials should NOT be present?
- What do you envision for this memorial on its 50th year anniversary, how does it age?
